#### 1 RULES

- 1.1 The event will be governed by the rules as defined in the World Sailing Racing Rules of Sailing <u>Windsurfing Competition Rules</u> (WCR).
- 1.2 The <u>Class Rules</u> shall apply, except as modified by this document.
- 1.4 If there is conflict between the Notice of Race and the Sailing Instructions (SIs), the SIs will take precedence.

#### 2 ADVERTISING

Boards may be required to display advertising chosen and supplied by the organizing authority. World Sailing Regulation 20 Advertising Code shall apply.

#### 3 DIVISIONS

- 3.1 The participating class shall be:
- 3.1.1 Raceboard Class Open

#### 3.2 Age Divisions:

3.2.1 There are no age divisions. For entry fee discount, Youth is under 20 years of age on the 1<sup>st</sup> April 2021.

#### 3.3 Weight Divisions:

3.3.1 There are no weight divisions

#### 4 ELIGIBILITY AND ENTRY

- 4.1 All entries shall meet the requirements of World Sailing Regulation 19-Eligibility Code.
- 4.2 Competitors shall be members of a Club affiliated with the AWA. This provides the third-party public liability insurance necessary to compete in this series.
- 4.3 Eligible competitors may enter by completing the entry form and making a bank transfer. Please use your surname as a reference:

#### 5 FEES

- 5.1 The required fees are as follows:
  \$160 for the entire series, including the States at Jervis Bay Sailing Club. \$70 for 2day heats, \$30 for 1-day events. Youth rate for the NSW Series is half price.
- 5.2 On-line payment of fees is encouraged. Individual round fees may be paid with cash before the briefing of that round.

#### 6 RACE FORMAT

- 6.1 The Series is composed of 6 events each of which shall be a single discipline, *course racing*, "open entry" event.
- 6.2 There shall be a maximum of 5 races per day.
- 6.3 One race is required to validate each event, with the exception of the State Titles, where three races are required to constitute the championship.
- 6.4 Three valid events are required to validate the series.

#### 9 EQUIPMENT & EQUIPMENT INSPECTION

- 9.1 Sailors may race with a board that is not on the <u>World Sailing list of registered</u> <u>boards</u>, but the board must conform to the class rules.
- 9.2 Sailors can use a maximum of 3 sails at each event (changes class rule C.8.1).

#### **10** SAILING INSTRUCTIONS

The sailing instructions (SIs) will be available at the events or prior via the WNSW website <u>www.windsurfingnsw.com</u>. Any changes to the SIs shall be approved by the Principal Race Officer and Class Representative at the event.

#### 11 COURSES

Courses will be as described in the sailing instructions.

#### 12 SCORING

- 12.1 Scoring will be according to the WCR Appendix A, and using the Low Points Scoring System.
- 12.2 Competitors can drop one race when 5 or more races are completed and a further race (total 2 races) when 9 or more races are completed. This changes WCR rule A2.
- 12.3 Two heats can be dropped over the series.

## 13 SAFETY

- 13.1 Every competitor shall wear a personal flotation device that shall conform to the minimum standard of ISO 12402-5 (level 50) or meets AUS Standards AS1499 & AS1512.
- 13.2 Competitors, friends, family and spectators will be required to comply with Covid-19 restrictions imposed by the NSW State Government or the relevant Sailing Club. Note that those restrictions may change at short notice based on NSW Public Health Orders and Australian Sailing guidance and may include cancellation of the regatta, limitations on the number of attendees or exclusion of attendees from some regions of NSW or other Australian States.

#### 14 PRIZES

- 14.1 Prizes will be awarded to the first three competitors over the whole series.
- 14.2 If there are 3 or more female competitors over the series then prizes will be awarded to the first 3 female competitors in that class, in addition to 14.1.
- 14.3 Other awards may be made at the discretion of the Organising Authority.

## 15 DISCLAIMER OF LIABILITY

It is the competitor's sole decision to enter this event and to start and or to continue to compete. By way of entering, competitors acknowledge and agree that participation in this event can be dangerous and accept that their participation is at their exclusive risk in every respect. In addition, by way of entering competitors shall hold harmless the organising authority, its officers, members, servants and agents and all other competitors in respect of all liability for injury to their person and or loss or damage to their property howsoever arising from their participation or intended participation in this event and acknowledge and accept that the organising authority, its officers, members, servants, agents and other competitors accept no responsibility in respect to loss of life, personal injury or loss or damage to property which may be sustained by reason of a competitor's participation or intended participation in this event or arising for whatever reason in connection with this event.

#### 16 INSURANCE

Each participating boards shall be insured with valid third-party liability insurance with a minimum cover of AUS\$ 1,000.000 per event or the equivalent. See 4.2.

## 17 RIGHT TO USE NAME AND LIKENESS

In registering for the event, competitors automatically grant to the Organising Authority the right in perpetuity to make, use and show from time to time at their discretion, any motion pictures, still pictures and live, taped or filmed television and other reproduction of them, taken during the period of the event, for the said Event as defined in the Notice of Race and Sailing Instructions in which he/she participates without compensation.
